# Terms & Conditions

- **Payment:** Payment in the form of a company cheque, credit card, direct debit is required prior to the start of the event. If paying by cheque please include your name, on the back of the cheque. Cheques are to be made payable to Knowledge Capital Services Pvt Ltd. If paying by direct debit, please ensure the remittance advice includes your organization name, invoice number and attending delegate name - this will avoid delays. Notify Organizers by fax or email of the date of transfer. Bank Transfer fees are the responsibility of the payer.

- **Refunds, Substitutions and Cancellations**

The organizers reserve the right to change the Dates, Timings and Venue in case of circumstances beyond our control.

All cancellations must be in writing and sent to our office. Cancellation of nominations 30 days in advance attract 10% cancellation fee for Indian delegates and 20% of the registration fee in case of International delegates. The balance amount will be refunded after the program by D.D/ Cheque or Fund Transfer.

Cancellation of nominations 15 days in advance attracts 50% fee for Indian delegates and 70% fee in case of international delegates.

Cancellation of nominations less than 15 days before the program is not accepted and no refund will be made. However change of nomination of the delegate is possible. No shows of the registered delegates will be billed as per the prevailing tariff.
